1. Promoter

This Promotion is organised and conducted by Professional Bull Riders Australia Pty Ltd (ABN 99 120 218 304) of Level 7, 279 Clarence Street, Sydney NSW 2000 (Promoter or PBR Australia).

2. Promotion

By participating in the PBR Monster Energy Tour Orange Invitational Ticket Referral Competition (Promotion), entrants agree to be bound by these Terms and Conditions.

3. Promotional Period

The Promotion commences at 12:01 am AEST on 8 September 2026 and closes at 2:30 pm AEST on 19 September 2026 (Promotional Period). Entries received outside the Promotional Period will not be eligible.

4. Compliance with Laws and Permit Requirements

The Promotion is conducted in accordance with applicable Australian laws and regulations. If a permit, approval, registration or authorisation is required, the Promotion is subject to obtaining and complying with it. The Promoter may vary, suspend or cancel the Promotion to the extent necessary to comply with any law, regulatory direction or permit condition.

5. Eligibility

The Promotion is open to residents of Australia who purchase a valid ticket to the 2026 PBR Monster Energy Tour Orange Invitational during the Promotional Period via their Fliicket account. The entrant must purchase a valid ticket but no separate or additional payment is required to enter the draw, and entry into the draw is free.

The following persons are not eligible to enter or win:

- the Promoter, its related bodies corporate, and their employees, officers, contractors, agents and representatives;
- any person involved in the conduct, administration, management, operation, verification, filming or promotion of the Promotion or prize draw; and
- any other person involved with PBR Australia in connection with the Promotion.

An entrant under 18 years of age must have the consent of a parent or legal guardian to enter and, if selected, to accept the prize.

6. Eligible Event

The Event means the 2026 PBR Monster Energy Tour Orange Invitational. The Promotion applies only to ticket purchases for the Event.

7. How to Enter

To enter, an eligible entrant must purchase a valid ticket to the Event through Flicket during the Promotional Period. Entries may be accumulated as follows:

Ticket Purchase

- One (1) entry for each eligible ticket purchased for the Event through Flicket during the Promotional Period.

Social Media Sharing

- **Five(5)** additional entry each time an eligible entrant shares the Event on social media using the unique sharing link generated and provided through the entrant's Flicket account and the share is tracked via Flicket.
- A social media share only qualifies if it uses the entrant's unique Flicket sharing link and is tracked and recorded through Flicket. A share made without that link, or which cannot be verified through Flicket, will not qualify.

Successful Referral Purchase

- **Ten (10)** additional entries each time another person successfully purchases a valid ticket to the Event using the entrant's unique Flicket referral link.
- A referral purchase only qualifies if completed through and recorded against the entrant's unique Flicket referral link. A ticket purchased by another method, or a referral that cannot be tracked and verified through Flicket, will not qualify.

Only eligible activity tracked, verified and recorded through the unique Flicket links in an entrant's Flicket account will generate entries. Entries cannot be awarded for sharing, referrals, ticket purchases or other activity occurring outside those links, including activity reported later to the Promoter.

Entrants can view the entries recorded for them in their Flicket account. The number displayed reflects eligible activity tracked and recorded by Flicket.

There is no entry cap. Standard ticket purchase costs and ordinary internet or data charges may apply.

8. Entry Validation

The Promoter may verify entries and entrants and disqualify invalid, manipulated, fraudulent, misleading or dishonest entries or conduct, or any breach of these Terms and Conditions.

Only completed and paid ticket purchases generate entries. Complimentary tickets and refunded, cancelled, voided, fraudulent or chargeback transactions are ineligible and associated entries may be removed.

Flicket's tracking and account records are the definitive record for determining whether an entry, share, referral or referral purchase qualifies. If activity is not recorded in Flicket against the entrant's unique link, or cannot be validated through Flicket, no entry will be awarded. The Promoter is not required to manually allocate or retrospectively credit entries for activity outside those links.

9. Prize

There will be **one (1) winner**. The prize is one (1) PBR Australia merchandise voucher valued at AUD \$200.00, redeemable online only through the Promoter's nominated online merchandise store (<https://shop.pbraustralia.com.au/>). The **total prize pool is AUD \$200.00**.

10. Voucher Conditions

The voucher is valid for twelve (12) months from the date it is issued to the winner, is not transferable, is not redeemable for cash, cannot be exchanged for another benefit, and is subject to applicable redemption terms. Any unused portion is forfeited on expiry.

11. Prize Draw

The draw will occur at 10:00 am AEST on Monday, 21 September 2026 online. Each valid individual entry will be input separately into a random electronic generator. The generator will select one (1) entry at random and the first valid entry selected will be the winner. The draw will be recorded. The Promotion does not include an elimination round, being a round in which entrants or players are eliminated before final selection.

12. Winner Notification and Publication

The winner will be notified via SMS and email using the contact details in their Flicket account and published on the Promoter's website. The winner has fourteen (14) days from notification to claim the prize. Entrants consent to publication of the winner's name and general location.

13. Unclaimed Prize and Redraw

If the original winner does not claim the prize within fourteen (14) days after notification, they forfeit the prize and a redraw will occur.

The redraw will use the clause 11 method, from remaining valid entries, and will be filmed. It will occur at 10:00 am AEST on 5 October 2026 if the original winner was notified on 21 September 2026, otherwise as soon as reasonably practicable after the full 14-day claim period.

The replacement winner will be notified through their Flicket account details and published on the Promoter's website in the same way. They have fourteen (14) days from notification to claim. The voucher is valid for 12 months from issue to that winner.

14. Limitation of Liability

To the maximum extent permitted by law, the Promoter is not responsible for technical failures affecting entry or tracking, incorrect or outdated contact details, unauthorised interference, or delay, loss or damage arising from participation or prize use. Nothing excludes rights under the Australian Consumer Law.

15. Cancellation or Variation

If circumstances beyond the Promoter's reasonable control prevent the Promotion proceeding as planned, the Promoter may modify, suspend or cancel it, subject to law and regulatory directions or approvals.

16. Privacy

Personal information may be collected, used and disclosed to administer the Promotion, verify eligibility, conduct the draw, contact and announce the winner, and award the prize. It will be handled under applicable privacy law and the Promoter's privacy policy.

17. Promoter's Decision

The Promoter's decision on all aspects of the Promotion is final, subject to applicable law.
