1. Promoter

This Promotion is organised and conducted by Professional Bull Riders Australia Pty Ltd (ABN 99 120 218 304) of Level 7, 279 Clarence Street, Sydney NSW 2000 (Promoter or PBR Australia).

2. Promotion

By participating in the 2026 PBR Monster Energy Tour Hawkesbury Invitational Scan and Win Competition (Promotion), entrants agree to be bound by these Terms and Conditions.

3. Promotional Period

The Promotion commences at 6:00 pm AEST on Friday, 4 September 2026 and closes at 9:30 pm AEST on Saturday, 5 September 2026 (Promotional Period). Entries received outside the Promotional Period will not be eligible.

4. Compliance with Laws and Permit Requirements

The Promotion is conducted in accordance with applicable Australian laws and regulations. If a permit, approval, registration or authorisation is required, the Promotion is subject to obtaining and complying with it. The Promoter may vary, suspend or cancel the Promotion to the extent necessary to comply with any law, regulatory direction or permit condition.

5. Eligibility

The Promotion is open to residents of Australia who, during the Promotional Period, complete the entry steps in clause 7. No purchase is required and entry is free. Ordinary internet or data charges may apply.

- the Promoter, its related bodies corporate, and their employees, officers, contractors, agents and representatives;
- any person involved in the conduct, administration, management, operation, verification, filming or promotion of the Promotion or prize draw; and
- any other person involved with PBR Australia in connection with the Promotion.

An entrant under 18 years of age must have the consent of a parent or legal guardian to enter and, if selected, to accept the prize.

6. Eligible Event

The Event means the 2026 PBR Monster Energy Tour Hawkesbury Invitational. The QR code for the Promotion will be displayed on venue screens and/or promotional posters associated with the Event during the Promotional Period.

7. How to Enter

To receive one (1) entry, an eligible entrant must, during the Promotional Period:

- scan the Promotion QR code displayed on a screen or poster;
- follow the QR code to the nominated online entry form;
- provide the requested contact details accurately; and
- successfully sign up to the PBR Australia mailing list and submit the completed form.

Only one (1) entry is permitted per person. Duplicate, incomplete, automated or multiple entries may be removed. An entry is complete only when the online form records a successful submission and mailing-list sign-up.

8. Entry Validation

The Promoter may verify entries and entrants and disqualify any invalid, duplicate, manipulated, automated, fraudulent, misleading or dishonest entry or conduct, or any breach of these Terms and Conditions.

The Promoter's entry-form and mailing-list records are the definitive record of whether an entry was successfully received during the Promotional Period. The Promoter is not required to manually allocate or retrospectively credit entries that were incomplete, not recorded or submitted outside the Promotional Period.

9. Prize

There will be one (1) winner. The prize is one (1) PBR Australia merchandise voucher valued at AUD \$200.00, redeemable online only through the Promoter's nominated online merchandise store at <https://shop.pbraustralia.com.au/>. The total prize pool is AUD \$200.00.

10. Voucher Conditions

The voucher is valid for twelve (12) months from the date it is issued to the winner, is not transferable, is not redeemable for cash, cannot be exchanged for another benefit, and is subject to applicable redemption terms. Any unused portion is forfeited on expiry.

11. Prize Draw

The draw will occur online at 10:00 am AEST on Monday, 7 September 2026. Each valid entry will be included in a random electronic draw. The first valid entry selected will be the winner. The draw will be recorded. The Promotion does not include an elimination round.

12. Winner Notification and Publication

The winner will be notified using the contact details supplied in their entry and published on the Promoter's website. The winner has fourteen (14) days from notification to claim the prize. Entrants consent to publication of the winner's name and general location.

13. Unclaimed Prize and Redraw

If the original winner does not claim the prize within fourteen (14) days after notification, they forfeit the prize and a redraw will occur.

If the original winner is notified on 7 September 2026, the redraw will occur online at 10:00 am AEST on Monday, 21 September 2026 using the method in clause 11 and from the remaining valid entries. If notification occurs later, the redraw will take place as soon as reasonably practicable after the full fourteen-day claim period. The redraw will be recorded.

The replacement winner will be notified using the contact details supplied in their entry and published on the Promoter's website. They will have fourteen (14) days from notification to claim the prize. The voucher is valid for twelve (12) months from issue to that winner.

14. Limitation of Liability

To the maximum extent permitted by law, the Promoter is not responsible for technical failures affecting the QR code, entry form, internet connection, submission or mailing-list registration; incorrect or outdated contact details; unauthorised interference; or delay, loss or damage arising from participation or prize use. Nothing in these Terms and Conditions excludes, restricts or modifies rights that cannot lawfully be excluded, including under the Australian Consumer Law.

15. Cancellation or Variation

If circumstances beyond the Promoter's reasonable control prevent the Promotion proceeding as planned, the Promoter may modify, suspend or cancel it, subject to applicable law and regulatory directions or approvals.

16. Privacy and Marketing Communications

Personal information may be collected, used and disclosed to administer the Promotion, verify eligibility, conduct the draw, contact and announce the winner, award the prize, and add entrants to the PBR Australia mailing list as disclosed at the time of entry. Personal information will be handled in accordance with applicable privacy law and the Promoter's privacy policy.

By completing the mailing-list sign-up, entrants agree to receive marketing communications from PBR Australia. Entrants may unsubscribe from marketing communications at any time using the unsubscribe facility provided in those communications. Unsubscribing after a valid entry has been submitted will not invalidate that entry.
